Product can be printed on Encad/Kodak, Hewlett-Packard DesignJet (2xxx/3xxx/5xxx), ColorSpan Displaymaker, Epson Stylus Pro (7xxx/9xxx), Mimaki JV4 and Roland Hi-Fi Jet.

Ink Dry Time

Varies with type and amount of ink, relative humidity and temperature.

Printing:	60-80° F, 50% Relative Humidity
Ideal Storage Conditions:	70° F, 50% Relative Humidity, store in original packaging.
Handling Requirements:	Due to absorptive nature of the coating, avoid touching the coated surface with bare skin. Always wear cotton gloves when handling inkjet-coated materials. Rolls are supplied with the coated surface wound out. When rolling graphics, always roll so that the thinner material is on the outside surface of roll.
Shelf Life:	1 year from ship date when stored in proper conditions.

Finishing/Lamination

Can be laminated with either pressure sensitive or low temperature thermal laminate. Before lamination, please allow image to dry for 24 hours.
