This product uses a premium grade saturated natural color paper with high tack adhesive used for the clean pick-up and transfer of lettering and graphics. The product sticks and lays flat to the exposed release liner and cut vinyl graphics to protect against wrinkling, tunneling and edge curling. The 4775 Premium Paper Transfer Tape is an exceptional premask for large format graphics and recommended for use over UV screen printed decals & lettering, four color process printing and weeded spot color.
